Hearing no further comment, the hearing was closed.



CITY OF MARSHALL ORDINANCE #2020- 09

AN ORDINANCE TO AMEND THE ZONING MAP OF THE CITY OF MARSHALL SO AS TO CHANGE THE ZONING OF A PARCEL OF REAL PROPERTY AT 119 N GRAND STREET, PARCEL #53-000-413-01, FROM THE ZONING DISTRICT OF PROFESSIONAL OFFICE SERVICE DISTRICT (POSD) TO TRADITIONAL RESIDENTIAL (R-3).

THE CITY OF MARSHALL, MICHIGAN ORDAINS:

Section 1. Pursuant to the authority granted in Section 7.1 of the Marshall City Code, the Zoning Map of the City of Marshall is hereby amended so as to change the zoning district for the below described properties from Professional Office Service District (POSD) to Traditional Residential (R-3).

Section 2. This Ordinance or a summary thereof shall be published in the Marshall Chronicle, a newspaper of general circulation in the City of Marshall qualified under state law to publish legal notices, within ten (10) days after its adoption. This Ordinance shall be recorded in the Ordinance Book and such recording shall be authenticated by the signature of the Mayor and the City Clerk.

Director of Public Safety Scott McDonald and Attorney John Sullivan discovered the Fireworks section of our City code was in need of revision during a review of fire related codes and ordinances. The proposed ordinance includes some changes in definitions, brings the ordinance more in line with state law, and addresses some safety concerns.

Mayor Caron opened the public hearing to hear public comment regarding the proposed changes to City Ordinance 134.30: Fireworks.

Hearing no comment, the public hearing was closed.

Moved Wolfersberger, supported Metzger, to adopt the changes to City Ordinance 134.30: Fireworks. On a roll call vote – ayes: Underhill, Wolfersberger, Mayor Caron, Metzger, McNeil, and Traver; nays: none. MOTION CARRIED.

City of Marshall, Michigan Ordinance #2020-10

AN ORDINANCE AMENDING CITY OF MARSHALL CODE OF ORDINANCES, SECTIONS 134.30

WHEREAS, The Michigan Fireworks Safety Act, MCL 28.451, et seq, as amended, legalized the sale, possession and use of fireworks in Michigan; and

WHEREAS, Section 134.30 of the Code of Ordinances is in conflict with the Michigan Fireworks Safety Act; and

WHEREAS, the public good is furthered by maintaining consistency and uniformity between the Act and local ordinance; and

WHEREAS, the health, safety and welfare of city residents, and visitors, is furthered by the enactment of an ordinance which regulates the ignition, discharge, and use of fireworks;

NOW, THEREFORE, THE CITY OF MARSHALL ORDAINS that the current version of Section 134.30 be deleted and replaced with the version set forth herein;

§ 134.30 FIREWORKS

(A) Definitions:

AGRICULTURAL AND WILDLIFE FIREWORKS. "Agricultural and wildlife fireworks" means fireworks devices distributed to farmer, ranchers, and growers through a wildlife management program administered by the United States Department of the Interior or the Department of Natural Resources of this state.

ARTICLES PYROTECHNIC. "Articles Pyrotechnic" means pyrotechnic devices for professional use that are similar to consumer fireworks in chemical composition and construction but not intended for consumer use, that meet the weight limits for consumer fireworks but are not labeled as such, and that are classified as UN0431 or UN0432 under 49 C.F.R. 172.101.

CONSUMER FIREWORKS. "Consumer fireworks" means fireworks devices that are designed to produce visible effects by combustion, that are required to comply with the construction, chemical composition and labeling regulations promulgated by the United States Consumer Product Safety Commission under 16 C.F.R. parts 1500 and 1507, and that are listed in APA standard 87-1, 3.1.2, 3.1.3, or 3.5. CONSUMER FIREWORKS does not include low-impact fireworks or novelties.

DEPARTMENT. "Department" means the Department of Licensing and Regulatory affairs.

FIREWORK or **FIREWORKS**. "Firework" or "fireworks" means any composition or device, except for a starting pistol, a flare gun, or a flare, designed for the purpose of producing a visible or audible effect by combustion, deflagration or detonation. Fireworks consist of consumer fireworks, low-impact fireworks, articles pyrotechnic, display fireworks and special effects.

LOW IMPACT FIREWORKS. "Low impact fireworks" means ground and handheld sparkling devices as that phrase is defined under APA Standard 87-1, 3.1, 1.1 to 3.1, 1.8 and 3.5.

MINOR. "Minor" means an individual who is less than 18 years of age.

NOVELTIES. "Novelties" means that term as defined under APA standard 87.1, 3.2, 3.2.1, 3.2.2, 3.2.3, 3.2.4 and 3.2.5 and include all of the following:

- A. Toy plastic or paper caps for toy pistols in sheets, strips, rolls, or individual caps containing not more than .25 of a grain of explosive content per cap, in packages labeled to indicate the maximum explosive content per cap.
- B. Toy pistols, toy cannons, toy canes, toy trick noisemakers, and toy guns in which toy caps as described in subparagraph A are used, that are constructed so that the hand cannot come in contact with the cap when in place for the explosion, and that are not designed to break apart or be separated so as to form a missile by the explosion.
- C. Flitter sparklers in paper tubes not exceeding 1/8 inch in diameter.
- D. Toy snakes not containing mercury, if packed in cardboard boxes with not more than 12 pieces per box for retail sale and if the manufacturer's name and the quantity contained in each box are printed on the box, and toy smoke devices.

PERSON. "Person" means an individual, association, charitable organization, company, limited liability company, corporation or any other legal or commercial entity.

SPECIAL EFFECTS. "Special effects" means a combination of chemical elements or chemical compounds capable of burning independently of the oxygen of the atmosphere and designed and intended to produce an audible, visual, mechanical, or thermal effect as an integral part of a motion

picture, radio, television, theatrical or opera production or live entertainment

- (B) No person shall ignite, discharge or use homemade fireworks at any time. A person who violates this section is responsible for a municipal civil infraction and shall be fined \$1000 for each violation and no other fine or sanction shall be imposed. \$500 of the fine shall be remitted to the Marshall Police Department.
- (C) No person shall ignite, discharge or use consumer fireworks except on the following days after 11:00 a.m.
 - (1) December 31 until 1:00 a.m. on January 1.
 - (2) The Saturday and Sunday immediately preceding Memorial Day until 11:45 p.m. on each of those days.
 - (3) June 29 to July 4 until 11:45 p.m. on each of those days.
 - (4) July 5, if that date is a Friday or Saturday, until 11:45 p.m.
 - (5) The Saturday and Sunday immediately preceding Labor Day until 11:45 p.m. on each of those days.

A person who violates this section is responsible for a municipal civil infraction and shall be fined \$1,000 for each violation and no other fine or sanction shall be imposed. \$500 of the fine shall be remitted to the Marshall Department of Public Safety.

- (D) No person shall ignite, discharge, or use consumer fireworks on public property, school property, church property, or the property of another person without that organization's or person's express permission to use those fireworks on those premises. A person who violates this section is responsible for a municipal civil infraction and shall be fined \$500.
- (E) No person shall discharge, ignite, or use consumer fireworks or low impact fireworks while under the influence of alcoholic liquor, a controlled substance, or a combination of alcoholic liquor and a controlled substance. A person who violates this section is responsible for a municipal civil infraction and shall be fined \$1,000.
- (F) No person shall smoke or use smoking materials within 50 feet of any area where fireworks or any other pyrotechnic materials are present. A person who violates this section is responsible for a municipal civil infraction and shall be fined \$500.

- (G) A minor shall not possess, use, discharge or ignite consumer fireworks at any time unless supervised by a parent or legal guardian. A person who violates this section is responsible for municipal civil infraction and shall be fined \$500.
- (H) No person shall discharge, set off or use an unmanned free-floating device (sky lanterns) which requires fire underneath for propulsion and which is not moored to the ground while aloft. A person who violates this section is responsible for a municipal civil infraction and shall be fined \$500.
- (I) No person shall ignite, discharge, or use consumer fireworks or low-impact fireworks in a manner that is intended to harass, scare, or injure livestock. A person who violates this section is responsible for a municipal civil infraction and shall be fined \$500.
- (J) If the police or fire investigator determines that a person has violated this ordinance, or the Michigan Fireworks Safety Act, the fireworks associated with the violation may be seized and stored as evidence. If the person subject to criminal or civil proceedings is found guilty or responsible, the person shall be required to pay the storage expenses for the evidence seized.
- (K) Notwithstanding the days and times permitting the ignition, discharge or use of consumer fireworks under § (B)(1)-(5), if the environmental concerns based on the Michigan Department of Natural Resources Fire Division criteria are elevated to extreme fire conditions or if the environmental concerns based on the Fire Division criteria are elevated to very high for 72 consecutive hours, the Director of Public Safety, or their designee, in consultation with the Michigan Department of Natural Resources, has the authority to enforce a no-burning restriction that includes a ban on the ignition, discharge, and use of consumer fireworks and display fireworks within the City. If a no-burning restriction is instituted under this section. the Director of Public Safety, or their designee, shall ensure that adequate notice of the restriction is provided to the public. Not more than 24 hours after the fire condition is downgraded from extreme or very high fire condition, the Director of Public Safety, or their designee, shall inform the public that the restriction has been lifted in the same manner that the restriction was announced or otherwise made known to the public. A person who violates this section is guilty of a misdemeanor.
- (L) The City reserves to itself the ability granted by the Act at MCLA § 28.466, to approve the use of articles pyrotechnic and display fireworks for public or private display by organizations and individuals within the City.
 - (1) The City Clerk, upon application in writing on forms provided by the Michigan Department of licensing and regulatory affairs, or its

successor agency, and payment of a fee to be established by resolution, may grant a permit for the use of articles pyrotechnic or display fireworks for public or private display within the City by organizations or individuals approved by the City Clerk, and compliance with the Michigan Fireworks Safety Act. A permit granted under this subsection is not transferable and shall not be issued to a minor.

- (2) Before a permit for articles pyrotechnic or display fireworks ignition is issued, the person applying for the permit shall furnish proof of financial responsibility by a bond or insurance in an amount, character and form deemed necessary as set from time to time by resolution to protect the public and to satisfy claims for damages to property or personal injuries arising out of an act or omission on the part of the person or an agent or employee of the person.
- (3) Before granting a permit, the Director of Public Safety shall rule on the competency and qualifications of an articles pyrotechnic and display fireworks operator, as furnished by the operator on the operator's application form, in accordance with the requirements provided under NFPA 1123, and on the time, place and safety aspects of the display of articles pyrotechnic or display fireworks.

Mayor Caron opened the public hearing to hear public comment regarding the proposed changes to Chapter 95 of the Marshall City Code of Ordinances.

Hearing no comment, the public hearing was closed.

Moved McNeil, supported Underhill, to adopt the amendments to the City Ordinances 95.03, and repeal Ordinances 95.04, 95.05, 95.06 and 95.99. On a roll call vote — ayes: Wolfersberger, Mayor Caron, Metzger, McNeil, Traver, and Underhill; nays: none. **MOTION CARRIED**.

City of Marshall, Michigan Ordinance #2020-11

AN ORDINANCE AMENDING CITY OF MARSHALL CODE OF ORDINANCES, SECTION 95.03 AND DELETING SECTIONS 95.04, 95.05, 95.06 AND 95.99

WHEREAS, the burning and combustion of materials directly into the environment causes the release of pollutants into the air which negatively impacts the human sight and respiratory systems; and

WHEREAS, the burning and combustion of materials directly into the environment increases the risk of uncontrolled fire, and generally creates a nuisance; and

WHEREAS, the health, safety and welfare of city residents, and visitors, is furthered by the enactment of this ordinance;

NOW, THEREFORE, THE CITY OF MARSHALL ORDAINS that the current versions of Section 95.03, 95.04, 95.05, 95.06 and 95.99 be deleted and replaced with 95.03 as set forth herein;

§ 95.03 PROHIBITED BURNING.

(A) Definitions:

BURN OR BURNING. "Burn" or "burning" means the ignition or combustion of material where smoke and other emissions are released directly into the air.

GARBAGE. "Garbage" means rejected organic waste including waste from the accumulation of animal, fruit, or vegetable matter used or intended for the use in the preparation, use, cooking, processing or storing of meat, fish, fowl, fruit, vegetable or other food; accumulations of leaves, branches, cut grass or other vegetation.

LITTER. "Litter" means all rubbish, refuse, garbage, trash, debris and waste material of any kind.

OWNER. "Owner" means:

- (1) Every person or entity holding legal or equitable title to a property or to real improvements on a property solely, jointly, by the entireties, in common, or as land contract vendee.
- (2) Every person or entity who in fact has been empowered to act on behalf of, or receive process for, or as agent of the owner; or
- (3) Every person or entity who has, or exercises, care, custody, dominion or control over any property;
- (4) Every person or entity who is a record owner as demonstrated by a deed or other document of title recorded at the office of the Register of Deeds or otherwise substantiated; or
- (5) Every person or entity listed as the taxpayer by assessor's records.
- (B) No person shall burn paper, garbage, litter, trees, leaves, stumps, brush, refuse, household waste, commercial waste, building materials or debris, construction materials or debris, demolition waste or debris, remodeling waste or debris, tires, furniture or any other wanted or unwanted material, except as otherwise provided herein. A person who violates this section is responsible for a municipal civil infraction and shall be fined as follows:
 - (1) For a first offense, a fine of \$100;
 - (2) For a second offense, a fine of \$300;
 - (3) For a third or subsequent offense, a fine of \$500.
- (C) No owner shall knowingly permit a person to burn paper, garbage, litter, trees, leaves, stumps, brush, refuse, household waste, commercial waste, building materials or debris, construction materials or debris, demolition waste or debris, remodeling waste or debris, tires, furniture or any other wanted or unwanted material on their property, or on property occupied by them or under their control, including the gutter or curb area adjacent to the property, except as otherwise provided herein. A person who violates this section is responsible for a municipal civil infraction and shall be fined as follows:
 - (1) For a first offense, a fine of \$100;
 - (2) For a second offense, a fine of \$300;
 - (3) For a third or subsequent offense, a fine of \$500.
- (D) For buildings or structures other than one and two-family dwellings, no person shall use barbecue grills, char broilers, smokers, deep fryers, and similar cooking or heat generating devices or appliances on balconies, decks, under any overhanging portion of a structure or within 10 feet of any structure, nor shall any person store said items on a balcony or deck. A person who violates this section is responsible for a municipal civil infraction and shall be fined as follows:

- (1) For a first offense, a fine of \$100;
- (2) For a second offense, a fine of \$300;
- (3) For a third or subsequent offense, a fine of \$500.
- (E) The following activities are excepted from the prohibitions set forth in (B),(C) and (D) above:
 - (1) The burning of buildings or other structures pursuant to fire suppression training authorized by the Director of Public Safety, or his or her designee.
 - (2) Burning authorized by a written permit issued by the Director of Public Safety, or his or her designee. Burning under this section shall only occur under the following circumstances:
 - a) The burn is supervised and controlled by the Marshall Fire Department;
 - b) The burn is of short duration;
 - c) The windspeed is less than 15 mph;
 - d) The Director of Public Safety, or his or her designee, may prohibit or delay permitted burns when atmospheric conditions or other circumstances are such that a fire would constitute a fire hazard or would endanger the life or property of any person.
 - Costs incurred for services provided by the Marshall Fire
 Department incident to permits issued to private persons or
 entities under this section shall be paid by the person or entity.
 - (3) Recreational fires under the following conditions:
 - a) The fire area shall be at least 25 feet from any building, structure or combustible material, and at least 15 feet from any property line:
 - b) The windspeed shall be 15 mph or less;
 - c) The fire area or pit shall not exceed 4 feet in diameter;
 - Only seasoned firewood, charcoal, compressed wood logs, compressed wood bricks or compressed wood barbecue pellets may be used in the fire;
 - e) The fire area must be supervised at all times by an adult.
 - f) A water supply, such as a garden hose, shall be readily available to suppress the fire;

- g) The duration of the fire shall not exceed four hours;
- h) The fire shall be fully extinguished before it is left unattended.
- i) The Director of Public Safety, or his or her designee, may prohibit recreational fires when atmospheric conditions or other circumstances are such that a fire would constitute a fire hazard or would endanger the health or property of any person.

(Prior Code, § 10-13) (Ord. passed 10-15-1984, Am. Ord. 2020-11, passed 6-1-2020)

All Ordinances or parts of Ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect, and the City of Marshall City Code shall remain in full force and effect, amended only as specified above.

If any section, clause or provision of this Ordinance shall be declared to be unconstitutional, void or illegal by any Court of competent jurisdiction, such section, clause or provision shall thereby cease to be a part of this Ordinance, but the remainder of this Ordinance shall stand and be in full force and effect.

SUBJECT: Annual Compensation of Administrative Officials,

Department Heads, and Salaried Personnel

BACKGROUND: The charter of the City of Marshall, Section 2.27, Annual Compensation states "The city council shall set the salaries of all administrative officials, department heads and salaried personnel by June 30 of every year, except as provided by State law. Such salaries shall be included in the annual budget..."

Attached is a listing, by job title, of the proposed wages for the administrative officials, department heads and salaried personnel. Performance evaluations were completed and a 3% wage increase is being proposed for all position.

These proposed wages are contained within the FY21 budget for the City of Marshall. All Union Groups are receiving a 3% wage increase by contract with the exception of Patrol and Command who are currently in negotiations. As indicated by Charter, the wages must be formally approved by Council.

RECOMMENDATION: Approve the proposed FY21 wages for the administrative officials, department heads and salaried personnel as presented.

<u>FISCAL EFFECTS</u>: The wages as shown on the attached listing, are included in the FY21 proposed budget.

FY 2020 Year-End Budget Amendments

BACKGROUND: Public Act 2 of 1968, better known as the Uniform Budgeting and Accounting Act, requires an amendment to the adopted budget when it can be determined that the budget projections will be different than originally anticipated. Each June, staff reviews the revenues and expenditures in order to develop an amended budget resolution to more closely reflect the actual operational costs and the associated revenues. All numbers in the "change column" that have a parenthesis, reflect a negative direction in terms of the budget. For example, if the "change column" for revenue has a parenthesis, then revenues are expected to be lower than originally budgeted.

The following is a summary of the recommended budget amendments:

General Fund

- Revenues are estimated to be \$40,325 higher than expected.
- Expenditures are estimated to be \$39,410 higher than expected.

Recreation

Revenues are estimated to be \$38,968 less than expected due to a slight decrease in property tax revenue and a much larger decrease in user fees related to the COVID 19 pandemic. Expenditures are estimated to be \$38,542 lower than originally budgeted.

Farmer's Market

Revenues are down \$11,815 and expenditures are estimated to be \$4,257 higher than originally budgeted.

MVH-Major Streets

Revenues are \$30,000 lower than expected due to lower Act 51 revenues. Expenditures are \$96,319 less due to timing of the Jefferson/Grand project.

MVH-Local Streets

Expenditures are lower due to fewer projects.

MRLEC

Revenues are slightly lower than expected.

Local Development Finance Authority

Revenues have increased due to higher tax capture and the sale of property.

Downtown Development Authority

Revenue and expenditures are both down due to the BluesFest being postponed.

Marshall House

The revenue decrease is due to an increase in turnovers for the year and holding some apartments open for the remodeling project.

<u>FiberNet</u>

The revenue decrease is due to the delay in the project, which resulted in a substantial decrease in the number of customers that were estimated to be hooked up to the FiberNet.

Electric

Revenue and expenditures are lower than expected due to the delay in construction/opening of the new commercial businesses that were to open in the spring of 2019.

Dial-A-Ride

Revenue and Expenditures are lower than expected due to the COVID 19 pandemic.

Wastewater

Revenues are estimated to be \$51,985 lower than expected due to lower than anticipated residential and commercial sales. Expenditures are estimated to be \$1,038,526 lower than expected due to the postponement of the AMI project.

Water

Revenues are estimated to be \$9,697 lower than expected.

Data Processing

Revenues and expenditures are both lower than expected.

Motor Pool

Revenues are \$107,970 lower than expected.

SUBJECT: Solid Waste Ordinance

BACKGROUND: At the December 3, 2019 Council meeting, a public hearing was held to consider the adoption of an ordinance that would allow the City to enter into an exclusive contract for trash collection in the City. After that hearing and a subsequent discussion at the Strategic Planning Work Session held on January 25, 2020, staff was directed to bring this issue back for discussion with a focus on trash and recycling only.

Attached is an updated ordinance that addresses some of the changes and highlights sections that need to be discussed. At the June 15th meeting, we will need to hold a discussion on what you want included and specific definitions in the ordinance. The following items/questions need to be covered in the ordinance:

- Who should be covered by the ordinance? Are four-unit buildings the limit? Condos?
- Do you allow opt outs for trash service? Require proof?
- Is recycling required for all customers?
- Do you include recycling charge in cost, but allow people not to take the service?
- Do we provide for seasonal service?
- Do you regulate where containers can be stored?

After the review and discussion, a final ordinance will be drafted and presented to Council on July 6th so that a public hearing can be scheduled on July 20th.

RECOMMENDATION: Review the attached draft ordinance and identify the issues that need to be included in a new ordinance.

Section 1. THAT TITLE V, PUBLIC WORKS, CHAPTER 50: GARBAGE AND RUBBISH READS AS FOLLOWS:

50.01 Definitions.

- A. "Brush" means twigs, brush, branches, and tree trunks not greater than eight inches in diameter.
- B. "Commercial garbage service" means the miscellaneous waste material, such as garbage, rubbish, and ashes, resulting from the operation of business enterprises and institutions. Such term includes construction waste, but excludes industrial trade waste.

- C. "Industrial waste" means accumulated on industrial or manufacturing premises arising from industrial, manufacturing, or chemical processing and includes, but is not limited to, metal scrap and solid or liquid chemical waste.
- D. "Recyclable materials" means refuse materials designated by the City Manager to be part of the City's recycling program and which are intended for transportation, processing and remanufacturing or reuse. Such items include, but are not limited to, the following: various grades of paper and cardboard, plastic bottles and jugs, glass, tin and aluminum containers and yard waste. Selection of the materials to be recycled will be at the discretion of the City Manager.
- E. "Refuse" means all manner of the same, including; but not limited to, ashes, rags, discarded clothing, discarded furniture, discarded appliances, tin cans, tin ware, bottles, broken glass, waste paper, motor vehicles or automobiles or trucks which are unlicensed and which are in inoperable condition, or motor vehicles which, although licensed, are abandoned, or motor vehicles which, although licensed, are dismantled, partly dismantled and/or in an inoperable condition and which remain in a dismantled, partly dismantled and/or in an inoperable condition for ninety days or more. The words "refuse," "trash," "rubbish," "litter," and "debris" shall be considered synonymous terms for the purposes of this chapter.
- F. "Residential refuse and residential garbage service" means service provided to premises having one and two-family residences, or multiple-family dwellings of less than four units.
- G. "Solid industrial waste service" means all trade wastes peculiar to industrial manufacturing or processing plants, including hazardous refuse, but not including commercial refuse
- H. "Yard waste" means leaves, grass clippings, weeds, hedge clippings, garden waste, twigs and brush no longer than two feet in length and one-half inch in diameter, and other organic material subject to natural composting as approved by the City Manager.

50.02 DISPOSAL OF REFUSE AND GARBAGE.

A. It shall be unlawful for any person to keep on or about premises owned or occupied by him or her any garbage, unless the same shall be kept in a watertight receptacle, which shall be kept tightly covered so as to prevent the access of insects or animals. The contents of such receptacles shall be removed

from the premises and properly disposed of at least once every seven days. However, if the owner of a premises occupied by a tenant or tenants shall furnish or cause to be furnished garbage pickup once every seven days for such tenant or tenants, such owner may not be prosecuted for violations of this section on such tenant-occupied premises during the period in which such garbage pickup was furnished.

- B. It shall be unlawful for any person knowingly to dump, deposit, place, throw or leave, or cause or permit the dumping, depositing, throwing, or leaving of garbage or refuse on any private property within the City.
- C. No person shall burn any garbage or refuse.
- D. No person shall burn any substance which shall, due to the nature of the substance or manner of burning, create or constitute a nuisance.

50.03 DISPOSAL OF INDUSTRIAL WASTE.

It shall be unlawful for the owner of premises and the occupant thereof to permit or suffer the accumulation of industrial waste on any premises in the City. Industrial waste shall be stored in receptacles and disposed of properly. Items of solid industrial waste too large to be stored in such receptacles shall be neatly stacked and disposed of properly at least once every three months. It shall be unlawful for any person knowingly, without the consent of the owner of private property, to dump, deposit, place, throw or leave, or cause or permit the dumping, depositing, placing, throwing, or leaving of industrial waste on private land in the City. Liquid industrial waste shall be disposed of in accordance with applicable State and Federal regulations.

50.04 DEPOSITS ON PUBLIC GROUNDS.

No person shall throw or deposit any garbage or refuse on any of the public streets, sidewalks, lanes, alleys, parks, cemeteries or other public grounds in the City at any time, including, but not limited to, the deposit of household garbage or refuse in garbage, trash or refuse containers located on any public street, sidewalk, lane, alley, park, cemetery or other public grounds.

50.05 EXCLUSIVE CONTRACTS.

The City Council shall, either by advertising for bids or otherwise, enter into an exclusive contract, with the mutual consent of the contractor, who shall be licensed, or extend the term of such contract, with such person as the City Council may deem best able to collect and dispose of residential refuse in the City in accordance with the best interests of the City and its residents. The contractor shall be the only person allowed to provide

residential refuse collection and disposal services within the City or within the boundaries prescribed by the limitations of this chapter. The contract documents shall contain provisions that the City contractor shall collect and dispose of refuse from all residential premises in the City in full compliance with this chapter and applicable local, State and Federal laws, rules, and regulations.

50.06 STORAGE OF CONTAINERS

From and after the passage and taking effect of this ordinance, it shall be unlawful for any person to leave their containers along any public way, street, alley, sidewalk, or other public property. Containers used for the disposing of said trash and rubbish shall be kept on the property's side or rear yards, in garages, car ports, homes, or other structures not in open view in front yards. Containers can be placed adjacent to the road within a period of time 24 hours before to 12 hours after any collection by a licensed hauler for the residential home involved.

50.07 TYPES OF COLLECTION SERVICES.

The contractor shall provide either curbside unlimited or backyard collection service one time per week and curbside recycling services as defined by this chapter to each residential premises either one time per week, or bi-weekly as may be determined appropriate by the City Manager. Curbside refers to that portion of a right-of-way adjacent to paved or travelled City roadways, excluding approved alleys. Backyard refers to a side or backyard or place that is convenient for both the City contractor and the customer, but in no case shall the City contractor be required to enter a garage or dwelling.

50.08 POLLUTION OF STREAMS.

No person shall cast or throw or cause to be cast or thrown into Kalamazoo River or Rice Creek, or into any of the streams or sewers leading thereto or into any pond or stream of water in the city, or into any ditch or drain in the city any garbage or litter.

50.09 RATES AND CHARGES.

If the City maintains any public disposal site, the City may establish, by resolution, any reasonable charge to offset, in part or total, the cost of operating the disposal facility.

50.10 LIENS; SPECIAL ASSESSMENTS; DEPOSITS.

Charges for residential premises refuse collection shall constitute a lien on such premises.

In addition to the methods of collection of fees imposed by or pursuant to this chapter, the Director of Finance shall, on June 30 and January 1, certify all unpaid charges for such service furnished to any premises which, as of such dates, have remained unpaid for a period of six months, to the City Assessor who shall place the same on a special assessment roll of the City.

50.11 ISSUANCE OF CIVIL INFRACTION CITATIONS AND NOTICES.

The City Manager and his or her designated representative is hereby designated as the authorized City official to issue Municipal civil infraction citations.

50.12 DISPOSAL OF YARD WASTE; YARD WASTE PICK-UP PROGRAM.

- A. No person shall place or deposit or cause to be placed or deposited, upon public or private property, any yard waste, except as provided by this section. This section shall not apply to grass clippings which are directly deposited back on the grass area from which they are generated or to yard waste which is part of a properly maintained compost pile or program.
- B. The City Manager is hereby authorized to establish a City-wide residential yard waste pick-up program and to establish rules and regulations for the implementation of the program.
- C. The rules and regulations for the collection of yard waste shall establish the dates for pick-up. No person shall set out for pick-up or cause to be set out for pick-up any yard waste prior to 5:00p.m. on the date immediately prior to the established pick-up date. Any yard waste set out subsequent to pick-up shall be removed from the curb lawn area within forty-eight hours by the owner, agent, or occupant of the premises in front of or adjacent to which the yard waste is located. Failure to remove improperly placed yard waste will result in the issuing of a Municipal civil infraction violation notice.
- D. The rules and regulations for the collection of yard waste will provide for the pickup of loose leaves.
- E. The yard waste pick-up program is not meant to circumvent the free-enterprise system of commercial lawn care companies. The City will not pick up yard waste generated by a commercial lawn care company.

50.13 DISPOSAL OF BRUSH; BRUSH PICK-UP PROGRAM.

A. No person shall place or deposit or cause to be placed or deposited, upon public or private property, brush, except as provided by this section.

- B. The City Manager is hereby authorized to establish a City-wide residential brush pick-up program, which shall include provisions for the collection of brush resulting from storm damage, and to establish rules and regulations for the implementation of the program.
- C. The rules and regulations for the collection of brush shall establish the dates for pick-up. No person shall set out for pick-up, or cause to be set out for pick-up, any brush prior to 5:00p.m. on the Friday immediately prior to the established pick-up date. Any brush set out subsequent to pick-up shall be removed from the curb lawn area within forty-eight hours by the owner, agent, or occupant of the premises in front of or adjacent to which the brush is located. Failure to remove improperly placed brush will result in the issuing of a Municipal civil infraction violation notice.
- D. The brush program is not meant to circumvent the free-enterprise system of commercial tree and brush removal. The City will not pick up material that is left as a result of a tree or lot being commercially cleared, removed, or pruned.

50.14 VACANT LOTS.

Any person owning or having a possessory interest in any lot or portion of land within the City which is vacant is responsible for securing, collecting and disposing of refuse which may accumulate thereon by contracting with a person licensed in accordance with this chapter or by self-removal through proper collection and storage of refuse, transporting the refuse in a manner to prevent littering or any other nuisance and depositing the same at an approved disposal area, in accordance with applicable local, State and Federal laws, rules and regulations.

50.15 ENFORCEMENT.

The City Manager or his/her appointee is hereby charged with enforcing this chapter.

50.99 Penalty

A person who violates any provision of this chapter is responsible for a Municipal Civil Infraction and shall be subject to the payment of a civil fine of not less than five hundred dollars (\$500.00), plus costs and other sanctions, for each infraction, including any costs of clean-up. The City Council shall adopt a fine schedule for violations of this ordinance.

Severability.

The various parts, sections and clauses of the Ordinance are declared to be severable. If any part, sentence, paragraph, section, or clause is adjudged unconstitutional or invalid

by a Court of competent jurisdiction, the remainder of the ordinance shall not be affected. Effective Date. This Ordinance shall be effective thirty (30) days after publication.
