












INTERNAL ROAD TYPICAL SECTION CONCRETE OPTION

SIDEWALK NOTES:

1. ONE-HALF INCH TRANSVERSE EXPANSION JOINTS SHALL BE PLACED THROUGH THE SIDEWALK AT UNIFORM INTERVALS OF NOT MORE THAN 1 EVERY 50 FEET.
